



COOKIES POLICY

Welcome to www.firstecn.co (the “Site”, “Website”). The Site is owned and operated by Nakito SA (the “Company”, “we”, “our”). When you access our website (“you”, “visitor”), we may collect identifiable or non-identifiable information with the use of cookies and log data.

Definitions

The following terms are used throughout this policy and are defined as follows:

“Cookies” are small text files that are placed on your computer/browser or device when you visit a website. Your computer stores it in a file located on your web browser. They are used to help your browser remember your choices and display personalised information instead of treating you as a new visitor each time you visit the website. Additionally, they are used in order to make websites work, to provide features, or to function more efficiently, as well as to provide information to the owner of the site such as pages visited, number of visitors etc. Some cookies also enable the display of relevant advertising when you move from site to site.

“Third Party Cookie” this is a cookie provided by a third party e.g. Google Analytics for which we have no control over.

“Session” If a cookie does not contain an expiration date, it is considered a session cookie. Session cookies are stored in memory and never written to disk. When the browser closes, the cookie is permanently lost from this point on.

“Persistent” these cookies stay in one of your browser’s subfolders until you delete them manually or your browser deletes them based on the duration period contained within the persistent cookie’s file

Depending on the cookie type we keep track of different activities and data. For a detailed list of cookies we use, please refer to the Policy below.



1. FirstECN Cookies

We employ various types of cookies on our website. Necessary cookies are essential for the functioning of the Company’s website(s) and enable visitors to navigate the site (necessary cookies). Additionally, we utilize performance cookies to track visitor interaction with our site, providing insights into time spent on the site and any encountered issues. Data collected from necessary and performance cookies does not personally identify you. However, opting not to accept these cookies may impact your overall experience on our site.

We may utilise functionality and/or advertising cookies to offer you a more personalised experience and deliver content that aligns with your preferences. Additionally, we use advertising cookies to track the effectiveness of our marketing campaigns. Please note, that the Company may collect personally identifiable information through the use of functional and advertising cookies.

By accessing our Site, we collect information that your browser sends whenever you visit a website or online service (“Log Data”). This Log Data may include but is not limited to, your computer’s Internet Protocol address (IP), browser type, the web page you were visiting before you came to the Site, and information you searched for on the Site and the services.

Functional cookies	These cookies are essential for running our Site. Without these cookies, our Site would not function properly. These are saved temporarily as login information and expire once the browser is closed.

<p>Analytical cookies</p>	<p>Analytical cookies allow us to analyse patterns of visitor behavior and we use that information to enhance the overall experience or identify areas of the website that may require maintenance. The collected data is anonymous (i.e. it cannot be used to identify you and does not contain personal information such as your name and email address and it is only used for statistical purposes.</p>
<p>Promotional cookies</p>	<p>These cookies are used to track visitors across websites. The purpose of these cookies is to display advertisements that are relevant and engaging for the visitor.</p>
<p>Preferences cookies</p>	<p>Preference cookies enable the Site to remember information that changes the way the website behaves or looks, like your preferred language or the region that you are in.</p>
<p>Third-party Cookies</p>	<p>We may use third-party cookies to help us collect anonymous statistics about how our Site is being used and provide you with</p>

	<p>further information that may be of interest to you. As part of this process, our third-party partners may set their own cookies during your visit.</p> <p>To the extent that those cookies are not strictly necessary for the provision of our website and services, we will ask you to consent to our use of cookies when you first visit our Website. Also, you can choose to disable or block these cookies in your browser but have in mind that this may affect the functioning of the Website.</p>

2. Managing Analytics Cookies

We utilize Google Analytics that uses cookies to track website visitors and their behaviour. By doing so, we can tailor the experience of our site to your preferences. The data created by the cookies is stored by Google and it is later utilized by it to assess the use of our site, and to generate reports on the activity of the site or internet.

3. Purpose of Using Cookies

FirtECN uses data collected from cookies to monitor and analyse the use of our site and for the technical administration of the website. This helps us improve site features and generate valuable data regarding the interests, characteristics, usage, and behavior of our visitors.

Additionally, we use cookies to integrate personalized settings and understand visitors' preferences for analytics purposes.



Occasionally, we set cookies to assist with site navigation, enhance user experience, or provide important information related to user interests. These cookies help us offer a customized experience, thereby improving our website and the quality of our services or products.

FirtECN may share aggregated information, including queries and offers generated from your use of the website, which includes non-identifying information and Log Data, with third parties for industry analysis, demographic profiling, and other commercial purposes. This also allows us to deliver targeted advertising about products and services. Any aggregated information shared in these contexts will not contain any personal information.

4. Managing Cookies

At FirtECN we respect your right to privacy, and we herein provide you the information to manage the cookies you receive from web services. In case you wish to use our platform essential cookies are necessary to the performance of our platform. Opting out of these cookies will affect the provision of the relevant services and platform's functionality. At any time, you can delete cookies by using the settings in your web browser.

If you decide to disable cookies from your web browser, you accept that our website and other websites may not function properly, and as a result, you may not be able to sign in.
